NOTICE TO EXHIBITORS

NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED which specifies any conditions as to acceptance.

ENTRY FEES SHALL NOT BE REFUNDED in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Show Committee. If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

REFUNDS of \$10.00 or less will not be issued due to the costs of processing.

CHANGES, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

CONFIRMATION OF ENTRY & JUDGING PROGRAM will be sent (via First Class USPS mail) to the address listed on the Official AKC Entry Form, as per AKC Rules and Regulations. **E-MAIL CONFIRMATION NOTICES WILL NOT BE SENT.** For information regarding an entry . . . please phone 320-963-7705.

ERRORS ON ENTRY BLANKS. Owners are responsible for errors in making out entry forms and no entry fee will be refunded in the event of such errors or cancellations of entries after the published closing time and date.

DOGS MAY ARRIVE ANY TIME PRIOR TO THEIR SCHEDULED JUDGING TIME. Dogs not required for further judging will be excused.

JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS. Handlers alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

ALL DOGS PRESENT MUST BE HELD ON LEASH OR CONFINED TO CRATES except when being judged.

CLASS CASH PRIZES will be paid in the ring to the person handling the dog. Claims for prize money must be made in the ring before the judging of that class is over and the Show Secretary's Office is to be advised at once. The show Secretary and the show-giving club disclaim any liability for cash prizes after judging of the classes in which the prize(s) are offered is over.
