## ROUTES TO SHOW SITE

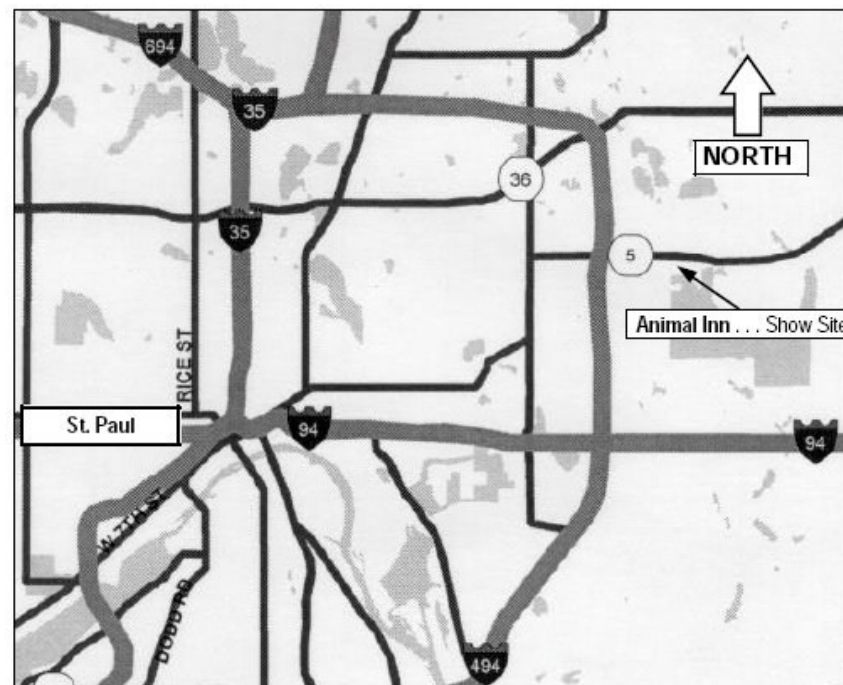
### Directions to Animal Inn Show Center

FROM THE NORTH: I-35 to I-35E at the split. I-694 East and South to Highway 5. Highway 5 East to Animal Inn on the right.

FROM THE SOUTH: I-35 to I-35E at the split. I-494 East and North to Highway 5. Highway 5 East to Animal Inn on the right. OR Highway 10 and 61 to I-494, then follow previous directions.

FROM THE EAST: I-94 TO I-694, I-694 North to Highway 5 and follow previous directions.

FROM THE WEST: Same as from the East.



## SHOW SITE

Floor covering is required beneath any crates placed on ring mats. The club will have some materials (plastic) available but appreciates exhibitors who provide their own material.

## SET-UP

**CONFORMATION EXHIBITORS** will have access to the show site building for set-up FRIDAY, FEB 10th between 6PM & 9PM only.

**OBEDIENCE & RALLY EXHIBITORS** will have access to the show site building for set-up SUNDAY, FEB 12TH at 7:00 a.m.

## CRATING

No overnight crating of dogs at show site or parking areas.

**EXHIBITORS . . . PLEASE NOTE**

**POST DATED CHECKS, AND RETURNED CHECKS** do not constitute a valid entry fee. The Secretary will add a collection fee to the amount of each returned check or declined card.

**NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.**

**ENTRY FEES SHALL NOT BE REFUNDED** in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Show Committee. If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

**NO REFUND FOR DUPLICATE ENTRIES.** Every effort to find all duplicate entries will be made; however, if the entry has been processed, no refund will be made.

**ERRORS ON ENTRY BLANKS.** Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

**DOGS MAY ARRIVE** any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

**JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

**ALL DOGS PRESENT MUST BE HELD ON LEASH OR CONFINED TO THEIR CRATES** except when being judged.

**CLASS CASH PRIZES** will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that Show is over, and the Secretary advised at once. The Secretary and show-giving Club disclaim any liability for cash prizes after the judging of the breed is over.

**ALL TROPHIES** must be claimed at the show . . . If not, they become the property of the Show Giving Club. **NO TROPHIES** will be mailed.

**COLLIE CLUB OF MINNESOTA, INC., RESERVES THE RIGHT** to substitute trophies with ones of equal or greater value.
